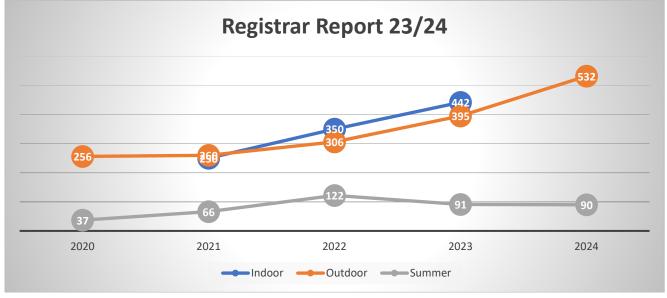

- SUSC Annual Indoor Tournament 2024: 151 registrations with 140 teams accepted from Saskatchewan, Manitoba, and Alberta (Increase of 35% over 2023 104 teams accepted).
- SUSC U13 Cup Outdoor 2024: 51 teams from Saskatchewan and Alberta, expansion to second location at Morris T. Chernesky fields. (Increase of 65% over 2023 31 teams accepted).
